Basic definitions related to data management

User: any natural person identified or can identified, directly or indirectly, by any personal data.

"data processor" means a natural or legal person or an organization without legal personality who, by virtue of a contract concluded with the data controller, including the conclusion of a contract by law, processes data;

Personal data breach: a breach of security leading to the accidental or unlawful destruction, loss, alteration, unauthorized disclosure of, or access to, personal data.
